Brief Note on the Seminar

The impact of the covid-19 on economies of all the countries is unprecedented and India is not exceptional to this phenomenon. Beyond disturbing the lives of general public, it has made severe damage to health, social interactions, particularly livelihood of millions of people, especially those in low-income jobs. Traditional notions of jobs and place of work were upended, as result new forms of work emerged. The advent of the new technology has facilitated netizens to use freely available apps and delivery platforms that in turn made an alternative mechanism to the traditional supply chains and logistics. This alternative mechanism has brought new terms such as 'flexible work' 'gig work', 'sharing economy' into the mainstream of the world. Though on demand-task based work is not new to India, the advent of the technology is bringing uncountable services by our electronic gadgets equipped with chiefly available internet data. As it is mentioned already, the revolution in telecommunications in India coupled with the need-based services paved a way to 'gig platforms. These platforms are able to create millions of employment opportunities to the unemployed by satisfying existing and new demand from the market. Yet, despite speedy penetration of gig economy into several sectors, it is felt that there is wider scope to explore further. Having realized that in knowledge-based economy, no economy is static and it changes over the time in all the dimensions for which it works, the government of India has taken many initiatives such as Atmanirbar Bharath to reboot the economy from the damage caused by covid-19. The digital economy, gig economy in India is considered as a golden opportunity for the people in the digital space to venture the business across the international frontiers. The size and the scale of digital economy in India offer a variety of business opportunities in the areas of gig economy. These opportunities may unlock productivity, savings, and efficiency across several sectors such as agriculture, education, energy, financial services, government services, health care, logistics, manufacturing, trade and transport. On the other side of the coin, India as a developing country is characterized by digital divide, low awareness on the usage of digital technology, low purchasing power, poor development of infrastructure, mismatch of income and expenditure etc. These bottlenecks may become as hindrances to avail the opportunities therein.
